consist of rare books, folios and maps, and archival holdings (primarily its own institutional archives) that are held for educational, research, and special curatorial purposes. Contributed collection items are not reflected in the financial statements.

All special collections are subject to appropriate stewardship measures (catalogued, preserved and cared for as appropriate and finding aids created). Proceeds from the sale of collections or insurance recoveries (of which there were none in 2017 and 2016) would be reflected as revenue resulting in an increase in unrestricted net assets.

Carnegie Library of Pittsburgh makes available to the public a collection of approximately 4.8 million books, periodicals, audiovisual items and other materials from the Main Library, the Library for the Blind and Physically Handicapped and 17 neighborhood locations. Most items may be borrowed by library cardholders for use at home, work, or school. Some unique, expensive, or frequently consulted materials are for use in the library only. This collection is the foundation for the Library's mission, which is to "engage our community in Literacy and Learning" and as such serves as the basis for the Library's tax exempt purpose.

Carnegie Library of Pittsburgh (CLP) records amounts for the Consortium of User Libraries (CUL) on their Statement of Financial Position. The CUL is an unincorporated association of libraries for the blind and physically handicapped licensed to use the automated registration, selection, and circulation system originally developed in 1976 by Automated Systems

Research and Development (ASRD). Software used by the CUL is officially owned by both Commonwealth Libraries of Pennsylvania and the State Library of New Jersey. Each member library shares the cost and planning of future development of the system.
