The Library's locations are open 996.5 hours a week, providing daytime and evening availability to customers of all ages and backgrounds. Most locations are open six days a week and four locations are open seven days a week, providing a welcoming space for all. Online resources--including eBooks, databases, music and career and educational resources--can be accessed online 24 hours a day, seven days a week.

As a free public library, Carnegie Library of Pittsburgh makes available to the public at no charge a collection of approximately 4.8 million items, access to the Internet, public wireless access (over 51 million minutes used in 2019), computers and other technologies, and reference and other services.

Every day, Carnegie Library of Pittsburgh supports Pittsburghers with early childhood education and out of school learning programs and myriad services for families, seniors, veterans, entrepreneurs and immigrants, among others. In 2019, the Library hosted more than 2.7 million visitors to its physical locations and more than 4 million

visits to its website. More than 5.4 million items, including eResources, circulated and approximately 14,000 programs and events were held with over 220,000 participants in attendance.

Carnegie Library of Pittsburgh reaches out to the community with programs and services to promote literacy and learning and increase awareness about the resources available in the Library. Our outreach programs enable the Library to share those resources with those who cannot come to the Library. Highlights of 2019 include:

- Children: Attendance at children's outreach programs reached 76,972 children. Over 3,000 programs were offered through outreach to a variety of early childhood centers, Head Starts, elementary schools and afterschool programs.

- Teens: Teen Specialists served their communities outside the Library walls by attending special community events and providing services to teens in their schools and afterschool programs. CLP promoted library services through Awesome Books for Middle Schoolers (formerly Teen Read Week), visited schools to promote Teen Summer Reading, and provided services to Pittsburgh Public School's Summer Dreamers Academy.

- Adults: Outreach efforts to adults of all ages continued with staff delivering books to various senior living facilities, installing "community collections," conducting booktalks, leading book discussion groups, and sharing technology.

- LYNCS (Library in Your Neighborhood, Community & School) provides an array of outreach services to adults with a priority on special populations, including seniors, immigrants, veterans, and the incarcerated, among others. This outreach focuses on building

relationships in communities that may face barriers to library service that limit access to critical information resources.

Carnegie Library of Pittsburgh - Library for the Blind and Physically Handicapped (CLP-LBPH) -- a network library of the Library of Congress National Library Service for the Blind and Physically Handicapped (NLS LBPH) -- served 15,047 individuals across the Commonwealth of Pennsylvania during the 2018-19 fiscal year. Staff answer reference questions, promote accessible technology, discuss the latest bestsellers and favorite authors and suggest new titles patrons might enjoy. The print and electronic collections offered by CLP LBPH include large print books, audio described DVDs, audio books and magazines, physical Braille books and downloadable audio and Braille services such as books and magazines offered through NLS LBPH. In recognition of its outstanding service to customers in 2018, CLP-LBPH was awarded the National Network Library of the Year. The award was presented to CLP representatives at the Library of Congress in 2019.

In 2019, 1,324 volunteers generously contributed more than 37,000 hours of service to support their neighbors and almost 4,000 individuals and organizations contributed financially to the Library to support essential services. With the support of our community, people of all ages have free and equal access to information and life-long learning opportunities.

Carnegie Library of Pittsburgh's 2018-2022 strategic plan includes specific goals and strategies to ensure that the Library fulfills its role as a community anchor, providing quality programs and services
